

# The Wonderful World of Air

## The fun begins with air!!

### Acknowledgement of Rules and Responsibility, and Release of Liability Agreement

**Deposit:** The lessee understands that The Wonderful World of Air requires a \$50.00 deposit to reserve any unit that is booked over 2 months in advance. The remaining balance will be due at the time of delivery. Rentals will not be reserved until deposit has been received. The lessee may reschedule within 90 days or cancel by calling The Wonderful World of Air. All cancellations (except weather conditions) will be subject to a non-refundable deposit.

**Weather Policies:** If an event is canceled due to weather conditions by The Wonderful World of Air representatives or by the lessee of equipment 2 hours previous to delivery time, the date can be rescheduled within 90 days of the original contract without losing any money. If the event is cancelled after the arrival of the equipment, the full amount will be due. However the event can be rescheduled within 90 days of the original contract date with a delivery charge of \$50.00. If the event is attempted and is shortened or altered due to weather conditions or any other related conditions, such as facility limitations, the event will be considered complete and all obligations satisfied.

### Responsibility of Lessee:

The lessee of the equipment will agree to provide:

- A separate 20 amp circuit for each blower used. Some inflatables may require 2-3 blowers. The lessee may have to obtain generators if sufficient power is not available. ( In the event the blower stops working, please ensure all users get off the inflatable immediately and calmly, check fuses and make sure the blower tube or deflation tube has not come undone or something has not blown onto it and is obstructing the blower.)
- It is the lessee's responsibility to tell The Wonderful World of Air where the inflatable is to be set up and have any underground utility lines marked prior too. The Wonderful World of Air is not responsible for striking or damaging any underground utility lines/devices (including but not limited to: electrical, plumbing, sprinkler, etc.)
- The proper amount of water hose(s) to allow the most efficient place for rental.
- 2 volunteers for each piece of equipment leased to supervise the use of the equipment.
- Detailed directions to the event and any emergency contact numbers needed for The Wonderful World of Air representatives to contact the lessee at anytime.
- The lessee agrees to pay in full for all damages to rental equipment. If the inflatable is lost, stolen, or damaged beyond repair the lessee agrees to pay for the unit in full.

### Rules and Maintenance of Rentals:

- Only compatible age groups and size shall use rental units. Always ensure that the inflatable is not overcrowded, and limit numbers according to the age and size of children using it. Try to avoid large and small children from using it at the same time.

- All users must REMOVE SHOES AND OTHER LOOSE ITEMS, SUCH AS JEWELRY, HAIR CLIPS, ANY SHARP ITEMS, ETC before entering the rental unit. To avoid injury or harm to the inflatable.

- Absolutely NO SILLY STRING, FACE PAINT, CONFETTI, DRINKS, FOOD, GUM, CANDY OR OTHER STICKY SUBSTANCES are allowed in the rental unit. (Please note these products will cause damage to the inflatable)

- Absolutely NO SMOKING, TIKI LIGHTS, FIREWORKS, or PETS on or anywhere near the unit.

- Absolutely NO HANGING ON NETTING THAT IS ON THE UNIT, CLIMBING, HANGING, OR SITTING ON WALLS.

- Absolutely no water on dry units.

(The lessee will be assessed a \$150.00 clean-up fee for any food/or drink spilled on equipment by members of lessee group)

LESSEE AGREES TO MAINTAIN THE EQUIPMENT IN THE SAME CONDITION AS RECEIVED.

Damaged Equipment:

The lessee will be responsible for damages due to:

- The site chosen by lessee for set-up of the equipment. (Once Set up do not attempt to move the inflatable)

- Lack of supervision by volunteers. (Please make sure there is a responsible adult to supervise at all times.)

- Abuse and/or inappropriate use of equipment.(Please ensure that children are not pushing, colliding, fighting, or behaving in a manner likely to injure or cause distress to others.)

(The lessee will be assessed a damage fee for any damages done to the unit.)

If an event is shut down due to misuse of the equipment by lessee, the event will be considered complete and all obligations satisfied.

Injury and Liability Waiver:

Understand that all reasonable precautions have been taken to assure that The Wonderful World of Air is as safe as possible.

The lessee acknowledges that inflatables and activities have inherent risk and may result in serious injury, paralysis, or death.

By leasing equipment from The Wonderful World of Air the lessee agrees to take responsibility for any damages or injuries that could occur in the use of specified equipment. Any claim(s) from injuries that may arise out of the use of specified equipment will be the lessee's responsibility. The lessee acknowledges that there are risks incidental to such participation. Accordingly, the lessee assumes the risk and dangers associated with said participation, including but limited to muscle strains and potentially serious injuries, disability, paralysis, that could result from falls including death. Lessee agrees to hold The Wonderful World of Air, its owners, its directors, its employees, manufacturers, sponsors, and subsidiaries harmless from any and all claims.

Lessee agrees to follow the safety and responsibility rules of The Wonderful World of Air and acknowledge failure to do so may result in expulsion for further rentals from The Wonderful World of Air.

ANY UNAUTHORIZED CHANGES MADE TO THE CONTRACT WILL CAUSE THE CONTRACT TO BE CONSIDERED VOID.
